#### Letter dated 27 October 2021

1. We refer to your letter dated 27 October 2021 (the letter).
2. We note that you have confirmed in writing the names of the lawyers of your complaint as Timothy Ang Wei Kiat (Hong Weijie) and Zhu Ming-Ren Wilson, both lawyers currently practicing in Rajah & Tann Singapore LLP.
3. We note that you have stated “ *I understand that my present complaint may not result in monetary compensation, and that my complaint will be sent to Ang and Zhu...*” and “*...My request for monetary compensation is nominal and clearly so in relation to damages prayed for in the matter of HC/S 413/2021, as well as symbolic in that it is a reiteration of my belief in an ethical law society and system in Singapore.*”
4. While we empathise with your situation, as informed in our letter of 26 October 2021, complaints of professional misconduct that are to be inquired into for the purpose of disciplinary action being taken against the lawyer(s) concerned.
5. Please note that the complaint process is **separate** from your own civil proceedings. Please also note that any ongoing or new civil suit for these matter(s) will be dealt with by the Court.
