You had promised to consider drafting our communication to NTU yesterday so I was hoping for your feedback. By when may Farallon Law contact NTU, and we may discuss our course of action in the likely event my request for reassignment is ignored or dismissed by NTU?

On at least two of the occasions we met or spoke on the phone you: (i) explained that contact with NTU should be initiated by Farallon Law sooner rather than later; (ii) assured me that Farallon Law is the ideal counsel for me; and (iii) kindly apologised for the delay in your replies. That you had missed vital text and attachment in an email of five lines and two attachments, five working days after I had sent the email, and that confidential documents I had sent you were not all in one place in Farallon's records are worrying. I find it difficult to reconcile these with the confidence you inspired in me, and the understanding you have shown. I have no doubt my interest is a priority well-placed within Farallon Law, especially given your reputation and that we have a strong case.

You will agree I have been patient and considerate, allowing a week to hear back from you before sending gentle reminders. I must insist we shortly develop a clear and timely course of action for my case. I would be very disappointed if Farallon Law does not have the capacity to prioritise my interest at this time. Should this be the case, I think I should be reimbursed, and hope any damages I incur for the associated delays will not be substantive.

Once again, I reiterate my gratitude for your support and understanding. I am depending on you and Farallon Law: to represent me in urgent proceedings with NTU, and to guide me through any legal obligations regarding the information I sent you.

I'm sending the boss' Animal Use Protocol (*RM AUP.pdf*). I think it's full of holes in NACLAR Guidelines and NTU IACUC SOP terms. I highlighted a paragraph on page 10 which should have sent alarm bells ringing.

I took the liberty of attaching documents with constrained access including my contract (*MH2.pdf* and *MH3.pdf*), and the NACLAR Guidelines for convenience. I don't know what's important, so I put in everything I have which might be. I apologise in advance.

I am keen for the opportunity of another consultation, and hope you may have time for me in the coming days or weeks.

I may settle with Nicolas as appropriate.

I don't think I mentioned it and stopped pursuing that evidence because my friend, the prof, told me it won't matter but I want to share this with you: what upsets me is the students that were probably demoralized. Their acknowledgements are identical, "...First / Foremost / Firstly [pick one] I would like to thank Asst Prof Mitra for the opportunity...." etc. I can see it in their Final Year Project reports. For example, one student wrote something like: "The results were not significant, maybe because we just counted the cells. We could have measured *area* of the cells but because measuring *volume* takes a lot of time, we didn't". I wish there was some way to tell those students: your message has been heard.
